

“Pets Domain” Revolution PLUS competition TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is Zoetis Australia Pty Ltd (ABN 94 156 476 425) of Level 6, 5 Rider Boulevard, Rhodes NSW 2138, Australia; telephone (02) 8876 0366.
3. Entry is only open to Australian residents who purchase a 3 or 6 pack of Revolution PLUS from a participating Pets Domain store during the promotional period (“Eligible Entrants”).
4. Eligible Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.
