## 4. First-aid measures

### Description of necessary first aid measures

<b>Inhalation</b>	Move to fresh air. Call a physician if symptoms develop or persist.

**Methods and materials for containment and cleaning up** Avoid discharge into drains, water courses or onto the ground. Avoid inhalation of dust from the spilled material. Ensure adequate ventilation. Remove sources of ignition. Avoid the generation of dusts during clean-up. Prevent release to the environment.

Large Spills: Stop the flow of material, if this is without risk. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.
